#### I. Opening Items

## a. Record Attendance and Guests

# d. March Board Retreat Update - Vote

The BoG is currently focusing on a strategic plan through 2025. A proposal was made to postpone the board retreat from March 11th to April 15th. Motion to postpone the board retreat until April 15th entered by BERGER and ARROM second the vote. The motion passed.

#### a. New Hire Introductions

## b. Academic & Instructional Comprehensive Needs Assessment Update

A five-day corporation visit was conducted in January by Making Schools Work to assess academic comprehensive needs. Lassiter presented highlights from each campus visit. On March 17, 2023, the full set of data will be available.

# c. Athletic Department Update

Lassiter presented an update on the recruitment process timeline and new criteria for an Athletic Director. April 1st is the projected start date for a new Athletic Director.

## d. Readers Become Leaders

ICES third graders are excelling in the NCAA/ICS/ICES "Readers Become Leaders" initiative and are advancing over other competing local third grade classrooms. Hendricks seconded this sentiment with compliments to ICES third students and staff.

#### e. Robotics

The RoboRavens are earning top rankings in the state and the nation and are currently world ranked. February 27th - March 3rd is RoboRavens awareness week. Mr. Stallard discussed the vision of RoboRavens and its impact on STEM education at ICS.

#### a. January Financials

## d. ESSER Budget Update

There is a solid understanding of what ESSER money is available. The funds need to be balanced and used sustainably, which will determine which projects can utilize that money and those resources.

# a. Advancement Committee Report

There are two current projects: 1) a popcorn fundraiser that will be completely virtual the week before spring break and 2) the Topgolf event scheduled for May 7th from 1-4pm. ## i. Balanced Scorecard - Mid-Year Update

The academic committee has received new members as well. There are three topics of current focus: curriculum review, the Soaring Ravens board, and the mid-year update.

#### ii. NWEA Progress - Mid-Year Update

The scorecard provides a series of academic metrics. Some topics include where the corporation is with graduation rates, earning credits, and academic growth. The percentage of students who met their academic growth was considered "approaching."

#### iii. Enrollment Update

Enrollment numbers are still in pandemic recovery, but on the rise. There is improvement in students selecting ICS as their first-choice school. Dehner gave updates on new family recruitment strategies and enrollment endeavors.
